

# PRIVACY POLICY

This Privacy Policy describes our practices with respect to Personal Information we collect from or about you when you use our website, applications, and services (collectively, "Services").

## 1. COLLECTED PERSONAL INFORMATION

Device Information pertains to the specifics of your device, such as its name, operating system, device identifiers, and browser. The data collected depends on the type of device you use and its settings.

Usage Data encompasses the information we gather about your use of the Services. It includes the content you view or engage with, the features you utilize, your actions, time zone, country, access dates, times, user agent, device type, and computer connection details.

Analytics involves the use of various online analytics products utilizing cookies. These tools help us analyze user behavior on our Services, leading to improved user experiences during your interaction with the Services.

## **2. USE OF PERSONAL INFORMATION**

The personal information provided directly by you or the devices may be used following purposes:
